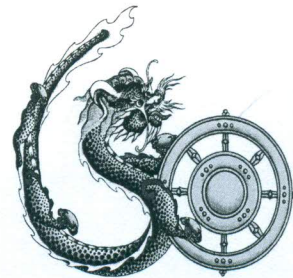

Invitation for Bids

The Dzongkhag Administration, Trashigang hereby invites sealed bids from eligible bidders registered with CDB for the construction and completion of Rangjung Water Supply Project ("the work").

1. The Kingdom of Bhutan (RGoB) has received financing from the Asian Development Bank (ADB) towards the cost of Secondary Towns Urban Development Project (STUDP). Part of this financing will be used for payments under the contracts named above. Bidding is open to Bidders from **eligible source countries of the ADB**. However, a successful bidder is required to register with the Construction Development Board (CDB) of Bhutan before award of contract.
2. The **Dzongkhag Administration, Trashigang** ("the Employer") invites sealed bids from eligible Bidders for the **Rangjung Water Supply Project** ("the Work").
3. National Competitive Bidding (NCB) will be conducted in accordance with ADB's Single-Stage: One Envelope Bidding Procedure and is open to all Bidders from eligible countries as described in the Bidding Document.
4. Only eligible bidders with following key qualifications should participate in this bidding:
 - a) **Key Construction Experience Requirement:** Participation in at least one contract that has been successfully or substantially completed within the last **5 (five)** years and that is similar to the proposed works (similar works means water supply works), where the value of the Bidder's participation exceeds: **Nu 31.916 million**
 - b) **Key financial requirement:** Minimum Average Annual Construction Turnover (AACT) of **Nu 66.492 million**
 - c) **Key equipment requirement:** (i) *Truck/Tipper* – 3; (ii) *Backhoe* - 1; (iii) *Hydraulic Excavator (PC 200)* – 1; (iv) *Concrete mixer (min cap 14/7)* - 1, (v) *Concrete Vibrator* - 2; (vi) *Leveling instrument/Total station complete set* - 1 & (vii) *Pipe jointing kit set* - 1; *Rock Drilling Machine* – 1; *Generator* – 1.
 - d) **Key personnel requirement:** (i) *Project Manager* – 1; (ii) *Project Engineer* – 1; (iii) *Site Supervisor* – 1; (iv) *Surveyor* – 1; (v) *Plumber* – 4; (vi) *Mason* – 3;

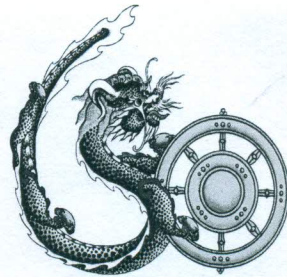


